GT solutions and Medline are proud to announce the deployment of the first electric truck dedicated to the distribution of healthcare products on March 14 at Medline's site in Le Coudray-Montceaux. This partnership marks a major step forward in the decarbonization of sensitive goods transportation.

The transport company GT Solutions has been supporting Medline Europe for seven years in distributing medical and surgical devices across France to healthcare companies. As part of its long-standing ESG strategy, Medline sought to reduce the carbon footprint of its product distribution and partnered with GT solutions to introduce its first electric truck.





The Vehicle Will Be Commissioned on March 14 in Le Coudray-Montceaux

This is the first time Medline's fleet will include an electric truck—an investment aligned with its ambitious sustainability project.
